Beverly Landers said she had sought outside of PCMS superintendent training. After discussion with staff and CBO Lisa Speegle, Mrs. Landers is confident working within PCMS at this time.

B. Independent Study Proposal/Master Agreement (attached)

CBO Lisa Speegle said PCMS has not offered an independent study program in the past 3-years due to families using it as an option for vacation time. She said not offering independent study to students could possibly have large fiscal repercussions. She said something to consider are students or teachers who have to be quarantined, or school closure due to Covid-19. If a policy is not in place, the school would have difficulty applying for emergency ADA funding. She realizes an IDS program would result in additional work for teachers, but the financial risk is significant. She said the policy could include stipulations such as students out for illness or quarantined only, not for vacation purposes.
